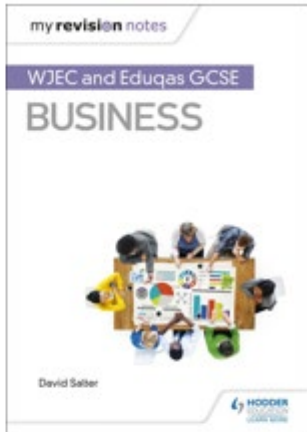

3. From the very beginning of the course, encourage your daughter to make handwritten revision cards (i.e: key term on one side and the meaning on the other side) of the key terminology from each topic. This should then be revised on a weekly basis, making preparation for the year 11 exams much easier, as all the revision cards would have been created over a period of time.

4. Encourage your daughter to keep abreast of business news, as this will make it easier for her to grasp the new concepts she will be introduced to in class. Some useful sites to visit are:

6. Encourage your child to make notes from the textbook and read around the subject, as widely as possible, as this will help her to better understand how: political, economic, social, technological, environmental and legal changes affect businesses.

7. Encourage your daughter to respond to teacher feedback, making improvements to their work and catching up on anything missed.

Year 11

Year 11 is all about helping your daughter to become 'exam ready'. Therefore, in addition to the above:

1. Encourage your child to spend time revising from their exercise books and revision guides.
2. Talk to your child about their learning in the subject and test them on their knowledge (i.e: start with the revision cards mentioned above). This practice will help your daughter commit the knowledge to her long-term memory.
3. Encourage your child to start revision early – this will also be beneficial for the mock examinations.
4. Encourage your child to be organised, using a revision timetable, and also to space out the different topics they study.
5. Encourage your child to attend the fortnightly after-school revision sessions run by the department.
6. Finally, encourage your child, as part of her revision and exam preparation, to attempt as many exam questions from the revision guide and exercise book as she possibly can and check her answers from the answer guide provided. This will help her to sharpen her skills prior to the exams and will also help her confidence.
